

Everyone Plays Recreation Program Scholarship FAQs



What is it?

The Everyone Plays Recreation Program Scholarship (RPS) is a program that provides tuition assistance for youth recreation programs administered through the NT Department of Youth, Recreation & Parks. The purpose of this program is to help children in families with limited financial resources participate in recreation programs and activities so that cost isn't a barrier to fun!

How does it work?

Applications from individuals who apply for the Everyone Plays RPS will be reviewed and approved by members of the North Tonawanda Youth Board. Approval will be based on meeting household income requirements, and submission of proper supporting documentation. Once the documents have been reviewed and approved, you will be placed in the program and you will receive a credit to be applied to your child's registration fees for specific youth programs.

Who can apply?

A parent or legal guardian of a youth who resides in the City of North Tonawanda that meets the income guidelines listed below.

How can I apply?

Obtain an application form from the North Tonawanda Department of Youth, Recreation & Parks (500 Wheatfield Street) or online at www.ntparksrec.com.

What documentation do I need?

You will need to provide a copy of your most recent 1040 tax return <u>OR proof</u> of enrollment/acceptance in either the NYS SNAP (Supplemental Nutrition Assistance Program) or Free Lunch Program through the NT School District.

What happens once I'm approved?

Once approved you will receive an email with instructions on how to proceed. Scholarships are awarded on a first-come-first-serve basis, and are distributed based on available funds. Individuals must have an online account with the www.ntparksrec.com site. Your account will be credited with an amount no greater than \$50 per child with a maximum of \$150 per household per calendar year. Levels of credit distribution will be determined based on available funds.

Where do the funds come from?

Funds come from fundraising efforts from the NT Youth Board. This includes special events, as well as solicitation of donations from the Everyone Plays "Sponsor a Kid" Program, where individuals give financially to specifically sponsor a child.

The North Tonawanda Youth Board, in association with the NT Department of Youth, Recreation & Parks has put into place a scholarship program providing funding for low income families to help cover the cost of enrollment in youth programs.
